

RECORD OF PROCEEDINGS
MINUTES OF ZANE TOWNSHIP TRUSTEES
October 10, 2022

The meeting was called to order at 8:00am by Chairman Steve Lithgo. Those present included Steve Lithgo, Doug Henry, Jack Graham, Rod Watkins, Tom Scheiderer, Jim King, Joni Cox, and John Smithers.

Steve made a motion to approve the September 12, 2022 regular meeting minutes. Seconded by Jack. Motion carries.

The Fiscal Officer presented all financials including invoices, checks, online payments, and mail (red folder).

Tom S. sent a certified letter to a resident regarding disabled vehicles and weeds on their property. Tom confirmed that the resident received such certified letter. Tom is currently checking on the zoning for a property owned by Penske Truck Leasing with regards to the possible expansion of their building.

Steve ordered the portable toilet for the park and will be delivered October 26, 2022. Allen Township and Zane Township Trustees will meet on November 30, 2022 to discuss the Fire & EMS contract amount for 2023.

Rod W. contacted Gary Fischer to close up the public restrooms at the park in November 2022. Rod stated that all inspections on road signs, culverts, playground, equipment, and vehicles have been completed this month.

Jack spoke to Henderson's about a new truck. They have gasoline trucks however the Trustees aren't interested in that. Kalida doesn't have anything now. Jack suggested looking for a new truck next year. Need to get an estimate of the value of the truck that will be replaced. Township Road 172 has been paved. Joe Hughes gave Jack a letter for the Logan County Commissioners concerning solar farms in Logan County. He asked the trustees to sign said letter in regards to stopping solar farms in Logan County Ohio and would pick back up and deliver to the commissioners.

John S. wants to put solar panels in his front yard. Said solar panels would be out of view due to the property having a deep lot and would be behind pine trees. Tom S. stated that he would need to submit an application with a permit fee and both Tom S. and Jim K. didn't have an issue with this as presented.
